-Do you have a green card?

-Are you getting public benefits?

နမ့်ပုလၢအဖိးန့ၣ်ဘၣ်ပဒိၣ်အတၢ်မၤစၢၤတဖၣ်န့ၣ်ဧါ.

If the answer is yes, you should read this. A new law might affect you and your family.

Recently, a law was passed that affects people with green cards. The law may affect you or your family if you receive Medicaid, Food Stamps, Cash Assistance, or Aid to the Aged, Blind, and Disabled.

-How do I know if this affects me?

- တၢ်ဂ့ၢ်အံၤမ့ၢ်ဘၣ်ထွဲဒီးယၤဒီးယကသ့ၣ်ညါအီၤသ့လၢကျဲၣ်လဲၣ်?

This change only affects people with green cards, so if you do not have a green card you are not affected.

-I have a green card, will I lose my benefits?

This depends on how long you have had your green card and how you entered the U.S.

တၢ်အံၤဒီးသန့ၤထီၣ်အသးလၢနဖီၣ်ယၢ်လံာ်အုၣ်သးကရံၣ်ခးဒ်ပှၤန့ၣ်လံာ်လဲၣ်အဖီခိၣ်ဒီးဖဲနခိၣ်ကီၢ်န့ၣ်လီၤလၢကီၢ်အမဲရ ကၢပှၤအခါ, နန့ၣ်လီၤအီၤလၢကျဲၣ်လဲၣ်န့ၣ်လီၤ.

If you have had your green card for 5 years or more, this law will not affect you.

နမ့ၢ်ပှၤလၢအဒီးန့ၣ်ဘၣ်တၢ်လံာ်အုၣ်သးကရံၣ်ခးဒ်အံၤ ၅န့ၣ်ဒီးဆူအဖီခိၣ်န့ၣ်, တၢ်ဘျၢအံၤတမၤဘၣ်ဒီးဘၣ်ထံးပ နီၣ်အတၢ်မၤစၢၤလၢနဖီခိၣ်န့ၣ်ဘၣ်.

Also, the law will not affect you if you entered the U.S. as a refugee, asylee, Cuban/Haitian entrant, Amerasian immigrant, Iraqi and Afghan Special Immigrant, or victim of trafficking.

-I entered the U.S. with a visa, will I be affected by this?

- ယန့ၣ်လီၤကီၢ်အမဲရကၢဒ်ပှၤဖီခိၣ်လံာ်အုၣ်သး visa ဘၣ်ဒ်တကလုာ်အသိး, လၢတၢ်န့ၣ်အယိတၢ်ဘျၢအံၤကမၤ ဘၣ်ဒီးဘၣ်ထံးပဒိၣ်အတၢ်မၤစၢၤယၢ်တဖၣ်န့ၣ်ဧါ.

Probably yes. If you entered the U.S. with a visa (student, spouse, U-Visa, etc.) and you have had a green card 5 years or less, the law will probably affect you.
